



Kativik Ilisarniliriniq (KI) est une commission scolaire proposant des services éducatifs dans les 14 communautés du Nunavik.

- Organiser des rencontres personnelles ou de groupe avec les élèves pour évaluer leur bien-être émotionnel et mental;
- Réagir aux élèves à risque en matière socioaffective et planifier des interventions avec les conseillers aux élèves;
- Travailler en collaboration avec le personnel de l'école pour planifier et organiser des activités de prévention dans une optique axée sur le traumatisme pour favoriser le bien-être social, émotionnel et mental des élèves;
- Préparer les rapports mensuels et documenter de manière confidentielle les interventions relatives à des élèves en particulier;
- Assurer un mentorat permanent en collaboration avec les conseillers aux élèves;
- Établir des relations efficaces avec les organismes communautaires locaux;
- En cas de crise à l'école ou dans la communauté, déclencher le protocole de gestion de crise de KI et y participer;
- Assurer, dans la mesure du possible, la participation des parents ou des tuteurs aux activités, programmes et interventions;
- Consulter les enseignants quant aux techniques et aux stratégies appropriées à adopter dans une classe de nature thérapeutique;
- Toute autre tâche connexe demandée par le supérieur immédiat.

La commission scolaire peut à son gré ne pas tenir compte des qualifications précitées si elle juge adéquate la candidature d'une ou d'un bénéficiaire de la Convention de la Baie-James et du Nord québécois (CBJNQ) et que la personne accepte de suivre un programme de formation déterminé par la commission.

Kativik Ilisarniliriniq (KI) is a school board serving educational services in the 14 communities of Nunavik.

Under the supervision of the Coordinator of Complementary and Compassionate Services, the role of the Student Support Professional is to prevent, promote, detect, and intervene in the psychosocial needs of students. The Student Support Professional will work closely with the Regional and Local Student Counsellors, and school staff, in an aim to support the students in their personal, social and emotional development.

The position includes in particular the following responsibilities:

FUNCTION & DUTIES:

- Meet with students individually and in groups to assess emotional and mental wellness;
- Respond to students at risk in the socio-affective domain and plan interventions with student counsellors;
- Work in conjunction with school staff to plan and deliver early prevention activities using a trauma informed lens that will aid the student's, social, emotional and mental well-being;
- Prepare monthly reports and document interventions related to specific students in a confidential file;
- Provide ongoing mentoring with collaboration of student counsellors;
- Develop effective liaisons with local community organizations;
- In crisis situations in the school and/or community, activate and assist with the KI crisis response protocol;
- Involve parents or guardians in activities, programs and interventions where possible;
- Consult with teachers on appropriate techniques and strategies of a therapeutic classroom;
- Any other related duties as requested by the immediate supervisor.

QUALIFICATIONS:

First level University Degree in a relevant specialization notably, psychoeducation, social work, youth work, etc.

The Board may, at its discretion, waive any or all of the afore-mentioned qualifications if it finds a suitable candidate who is a beneficiary of the James Bay and Northern Québec Agreement (JBNQA) and who accepts, as a condition of employment, to follow a training plan determined by the Board.

REQUIREMENTS:

- Fluency in 2 of the 3 languages of the board (Inuktitut, English and French);
- 2 years of relevant experience;
- Experience in youth centres, youth detention centres, or disintoxication centres is considered as an asset;
- Any working experience in a northern or remote area or in an intercultural environment is considered as an asset;
- Member of the 'Ordre des psychologues du Québec' or 'Ordre professionnel des travailleurs sociaux du Québec' is considered as an asset;
- DEC in special care counselling (asset).

WORK SCHEDULE: 35 hours per week from Monday to Friday.

SALARY / BENEFITS:

In accordance with the SPPOM collective agreement for professionals / from \$45 420 to \$78 640 annually depending on qualification and experience.

In addition to salary, you may be eligible to other benefits such as:

- 20 days of annual vacation
- 2 weeks of vacation during Holiday season

and, when applicable, other benefits such as:

- Northern allowance
